

RAPID REPAY PROGRAM TERMS AND CONDITIONS

1. Engagement

(a) Thank you for accepting our offer to present Rapid Repay in partnership with the Infinity Group Australia. By placing an Order, you acknowledge that you have read these Terms and Conditions and agree that the placement of an Order, together with these Terms and Conditions, forms a contract between you and Success Resources Australia Pty Ltd and that you agree to our privacy policy - <https://success-resources.com.au/privacy-policy.html>

(b) Rapid Repay will include:

(i) A Full Time Private Money mentor and financial coach allocated to you

(ii) Weekly contact with a financial coach and money mentor

(iii) Monthly performance reports on your family's debt reduction performance

(iv) 12-month subscription to the Infinity family, coaching, events, products, services, and software portal

(v) 12 months of financial coaching and reporting with access to both Cloud based and App based software wealth portal to manage your finances daily.

(vi) Full financial audit of: Insurances, utility and Telecommunications providers, current lending structure, rate, product and much more (vii) Access to Investment opportunities and Joint Venture investment considerations with Graeme Holm directly, developments, funds, business etc.

(b) if a payment plan has been agreed with Success Resources Australia Pty LTD, the installment amount in full as per the amount and date agreed when placing an order for Rapid Repay

(c) Installment due date will take place on the same date initial deposit is made, unless this falls after the 27th of the month, whereby the 27th will be used as the instalment date
