Engagement

1. (a) Thank you for accepting our offer to present the seminar service 'Virtual Unleash the Power Within 2020' to you, scheduled to take place on the 17-20th September 2020 (Australian Eastern Standard Time AEST). By placing an Order, you acknowledge that you have read these Terms and Conditions and agree that the placement of an Order, together with these Terms and Conditions, forms a contract between you and Success Resources Australia Pty Ltd and that you agree to our privacy policy - <https://success-resources.com.au/privacy-policy.html>

(b) In these terms and conditions, the following term seminar service(s) will cover all or any of the following and will apply to this order:

- (i) Access to the Virtual Unleash the Power Within 2020 - 17-20th September 2020 (AEST)
- (ii) Tickets to live seminars and/or online digital seminars
- (iii) Ongoing Mentoring or coaching
- (iv) Tangible products
- (v) Online or virtual resources

Time and Place

2. Your payment of the Investment to Success Resources Australia Pty Ltd entitles you to:

Investment and Payment

Cancellation Rights

7. A power or right may only be waived in writing, signed by the party to be bound by the waiver.

17. Should any provision of this agreement be held by a Court of competent jurisdiction to be unlawful, invalid, and unenforceable or in conflict with any rule, statute, ordinance or regulation the validity and enforceability of the remaining provisions will not be affected.

18. These Terms shall in respects be governed by the laws of New South Wales, Australia. You submit to the exclusive jurisdiction of the courts in New South Wales to determine any matter or dispute which arises under these Terms.

19. This agreement constitutes the entire agreement between the parties. Any prior arrangements, agreement, representations or undertakings are superseded.
