FEAR INTO POWER - THE FIREWALK EXPERIENCE

In consideration of my participation in this seminar and by my endorsement below, I agree to release and hold harmless Anthony J. Robbins, Robbins Research International, Inc. GENERAL RELEASE and INDEMNITY

In consideration of my participation in the seminar presented by RRI and its promoters, I hereby generally release Anthony Robbins, Robbins Research International, Inc., Success Resources Australia Pty Ltd and Sydney Olympic Park Authority for any liability whatsoever related to my participation in this seminar and indemnify each of the aforesaid from any loss or liability arising from any claim arising out of my participation in the Seminar in general and the firewalk in particular. I execute this Release with the express intention of effecting the legal consequences provided by section 5L of the Civil Liability Act 2002 (NSW), that is, the release of all liability associated with the Unleash the Power Within seminar.
